- When fire authority is convinced, get the fire challan and submit it to the client.
- Obtain Provisional Fire NOC after challan amount is paid by the client.

### ARTICLE: 2 FIRE PROTECTION CONSULTANCY SCOPE OF WORK

- 2.1 Consultation and review of fire protection requirements as addressed in the Provisional Fire NOC, local codes and NBC 2016.
- 2.2 Preparation of fire protection drawings.
- 2.3 Design of sprinkler system, hydrant system, fire alarm and public address system as per NBC and IS codes.
- 2.4 Review of architectural, electrical, HVAC, plumbing drawings for coordination purpose.
- 2.5 Interim inspections of job site to verify adequacy of fire protection system installation.
- 2.6 Witnessing final acceptance tests for newly installed fire protection systems.

- 3.1 Fire Liasoning Consultancy Fees: Rs. 25,000/- one time.
